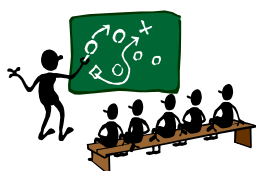

Waiver & Release South River—Machar Youth Soccer June 29, 2017 - August 3, 2017

In consideration of the Village of South River and Township of Machar as part of the summer youth soccer:

I hereby waive, release/absolve and agree to indemnify and save harmless The Village of South River and Township of Machar and its directors, officers, employees and agents of and from any and all liability arising therefrom, except such as shall arise solely as a consequence of its or their gross negligence or gross default.
